

- Q. Do you have any Hunting Permits available?
- A. Available Permit Areas are posted on our website. If there aren't any Permit Areas posted, we do not have anything available at that time.
- Q. How long will the Hunting Permit run?
- A. Each Hunting Permit runs for a period of one year (July 1 through June 30 of the following year).
- Q. How do I lease land from Four Rivers?
- A. Potential Permittees must contact Four Rivers to lease the desired property.
- Q. What methods of payment does Four Rivers accept for payment of the Permit Fee?
- A. Cashier's check, Hunt Club check or money order are acceptable forms of payment.
- Q. Can I lease out a portion of the property to someone else?
- A. No. Subleasing is explicitly prohibited in the Permit and discovery of subleasing will result in immediate termination of the Permit without a refund.
- Q. Can I use the Permit Area for commercial hunting or other commercial gain?
- A. No. The property is only to be used for the private, personal enjoyment of the hunting, fishing and other recreational rights granted to the Permittee. Discovery of commercial use of the property will result in immediate termination of the Permit without a refund.
- Q. Can I hunt deer with dogs on the Permit Area?
- A. On tracts identified as dog-hunting tracts, Permittees may hunt deer with the aid of dogs.
- Q. Can I camp on the Permit Area?
- A. Four Rivers allows camping in certain areas with approval from the Lease Manager.
- Q. Does the rate include liability insurance?
- A. No. Four Rivers requires that the club maintain liability insurance to the standards set forth by Four Rivers. Four Rivers facilitates a group policy which is available to Permittee at their cost.
- Q. Will my Permit Fee increase each year?
- A. Rates are evaluated each year to ensure that they remain competitive with the markets and will be adjusted by Four Rivers as needed. Rates for the upcoming Permit cycle are generally sent out in February, at which point the Permittee communicates their intent to renew the lease.
- Q. Can I harvest antlerless deer on the Permit Area?
- A. Yes. Antlerless deer may only be harvested on our Florida properties when Permittee Parties are in possession of an antlerless deer tag issued to Four Rivers from the Florida Fish and Wildlife Conservation Commission (FWC).
- Q. Am I allowed to install gates on the Permit Area?
- A. It is the responsibility of the Permittee to secure their Permit Area, which includes gating external access points and maintaining a club lock on the gate. Four Rivers will also maintain a company lock on the gate, which must not be locked out at any time. New gate installations must be approved by the Lease Manager prior to installation. The Permittee shall also post "No Trespassing" signs on their Permit Area according to Four Rivers' standards.
- Q. May I plant food plots on the Permit Area?
- A. Food plots may be established solely at the risk of the Permittee in areas where trees are not growing. No timber is to be damaged in the installation of the food plot.
